1. **GENERAL:** The school is running under **Sarvathitha Educational Society** with Registration No. **374/1995, Dt: 20.01.1995** with education classes **Class VI to X (EM)**. A copy of the society registration and bylaws copies enclosed. And there are no any complaints / court cases pending against the society as reported by the inspecting officer.
2. **Permission:** The RJDSE, Hyderabad, L.Dis.No.0010/B4/2025, Dt: 13.05.2025 has been accorded permission to Class Pre Primary to X (EM) during the year 2025-26 Opening Permission.
3. **APPLICATION FEE:** The Management has remitted an amount of Rs. **5000/-** Towards inspection fee to the Government Exchequer vide Challan No: **6500752888, Dt: 26.05.2025**, through SBH **Suryapet** branch. The Original Challan is enclosed.
4. **ENDOWMENT FUND:** The Management has created an amount of Rs **50000/-** towards endowment fund. The Xerox copies of the receipts are enclosed.
5. **ACCOMMODATION:** The school consists of **40** Rooms Provided in the slab rooms, **40** Class room used for class rooms and remaining rooms used for the Headmaster & Office room, Staff room, Laboratory, Games room. The Sketch Plan of the building, Structural Soundness Certificate, and Ownership Certificates are enclosed.
6. **STAFF:** There are **(40)** teachers are available in the school, of them Head Master, SA, SGTs, PET, along with Non-Teaching staff are working in the school. All are qualified, and their qualification certificates are enclosed.
7. **STRENGTH PARTICULARS:** The following Class - wise strength is available in the school:

11. LIBRARY: There are different categories & titles (1000) Books have been provided by the Management in the School Library. The list of Library Books is enclosed.
12. PLAY GROUND: The Management has provided an extent of **2000 Sq. Mts.** Sq. mts of Play Field is in the school premises /annexed to the school. And Games material also provided. List enclosed.
13. GOVERNING BODY & P.T.A: The list of Governing Body constituted and P.T.A formed and copies of the resolution and members lists are enclosed.
14. SALARIES: The Management has paid the salaries to the Staff as per rates fixed by the Governing Body.
15. LEE PARTICULARS: The Management is collecting fee from the students as per the rates fixed by the Governing Body resolution.
16. FIRE CERTIFICATE: The Management is Providing all fire safety equipment to the Students and requested for Exemption as per G.O.Ms.No 154/2007.
17. TEXTS & SYLLABUS: The Management has scrupulously following the Text Books and Syllabus fixed by the State Government. The First Language is 'Telugu'.
18. The Management is being encouraged the students to participate in the Saksharatha Programmes and also conducting the National Festivals like Republic Day, Independence Day, Teachers Day and Self Government Day etc.
